BOARD MEMBERS IN THE NEWS

Joe Mayer, EDC Chair, was featured in *SpaceCoast Business* magazine's *Up Close* profile discussing his career with Lockheed Martin as the Director, Government Relations - Florida and the company's extensive economic impact on the Space Coast.

Joe Mayer, EDC Chair, was nominated to serve on the Board of Directors for Visit Florida. Mayer will represent the Space Tourism industry. Visit Florida is the state's official tourism marketing corporation and Florida's official source for travel planning to visitors worldwide.

Lockheed Martin (Joe Mayer) announced the remodeling of the 58,000 square-foot U.S. Astronaut Hall of Fame in Titusville. This building will house the assembly of its Orion spacecraft, the capsule for NASA's upcoming moon missions.

Orlando Melbourne International Airport (Mark Busalacchi) announced its new program, *MLB's Game Plan: A Safe and Strategic Response to COVID-19,* which provides a safe and healthy environment for all passengers and employees. The program includes impactful changes throughout the terminal and a new interactive website www.FlyMLBsafely.com.

Bart Gaetjens, EDC Treasurer, Area External Affairs Manager at Florida Power & Light Co. was named LEAD Brevard's 2020 Leadership Brevard Distinguished Leadership Alumni. Gaetjens is a 2016 Leadership Brevard graduate. The award recognizes his leadership capacities displayed across more than twenty community organizations.

L3Harris Technologies (David Kornick) is continuing to expand its Space Coast operations in the aerospace and defense technology sector, despite the challenges of the COVID-19 pandemic. The Melbourne-based company is one year into a company merger worth \$33.5 billion that brought together the former Harris Corp. and L3 Technologies Inc.

Collins Aerospace (Lisa Steffen) received the *Women in the Workplace Champion Award* from weVENTURE during its *2020 Women Who Rock Awards*. The awards celebrate companies and individuals who prioritize diversity in leadership ranks. Collins Aerospace was nominated by the EDC because 45% of its local manufacturing workforce is female – well above the industry average of 29%.

Florida Institute of Technology (Capt. Winston Scott) manufactured face shields using its 3D printers at the Center for Advanced Manufacturing and Innovative Design. Members of the college's staff delivered face shields to organizations and communities across the Space Coast.

Regions Bank (Valia Rich) was featured in *Brevard Business News* for its role in assisting small businesses throughout Brevard with securing a Paycheck Protection Program (PPP) loan. Nationwide, Regions Bank will have saved or help support more than 600,000 jobs in the communities it serves.

The Viera Company (Todd Pokrywa) placed fifth in Florida and 13th in the nation in the mid-year results of the *Top–Selling Master–Planned Communities (MPCs)* survey. The MPCs is a national survey conducted by RCLCO Real Estate Advisors for the past 26 years. Viera's ranking is a significant leap from its ranking of 25th for the same period last year. Since last year, Viera has had a 41% increase in sales.

Melbourne Regional Chamber of East Central Florida (Todd Pokrywa) received the U.S. Chamber of Commerce's 5-Star Accreditation for positive economic impact on the Space Coast. The accreditation was earned through a review of the chamber's organizational procedures, effective advocacy efforts, and valuable programs.
